JOINT – CFAPW	Conflict-Free Access & Planning Workgroup Standing Update: The 7/28 meeting consisted of mostly breakout group sessions. Contrasting viewpoints between consumers/advocates and CMHSP/PIHP representatives regarding person-centered planning and medical necessity of services. There is a growing advocacy movement toward using independent facilitators however this often leads to increased frustration for consumers when the IF writes things into the plan that are not allowable by Medicaid or compliant with HCBS, behavior treatment, etc. Workgroup participants from the MSHN region share the opinion that there is already a foregone conclusion at the state level and feedback from the workgroup is a formal exercise. There is still lack of clarity regarding the statutory regulations or other source material that is being used by MDHHS to arrive at the interpretation that different functional areas must be completely separated (assessment, planning, authorization, etc) rather than considering models that build on current safeguards within the system.

JOINT - MICAL & OPEN BEDS UPDATE	MDHHS/LARA has indicated that it will require inpatient psychiatric units to use Open Beds. MDHHS recently hosted a small group discussion with representatives from several PIHPs/CMHSPs to provide feedback about their processes when seeking hospital admissions. MDHHS intends to use this feedback to help inform protocols for using the Open Beds register including required timeframes for hospitals to review and respond to referrals within the system.
